Mecklenburg County Sheriff's Office Remains Committed to Residents, Families and Friends Staying Connected and Reopens Visitation at the Detention Center for Father's Day Weekend

(CHARLOTTE, NC) – Mecklenburg County Sheriff Garry L. McFadden is committed to helping residents maintain their connections with families and friends while housed at the Mecklenburg County Detention Center during the pandemic and will reopen the detention center for face to face visitation for Father's Day weekend.

The Mecklenburg County Detention Center will reopen on Friday, June 18th through Sunday, June 20th for non-contact face to face visitation. Public scheduling for the 25-minute visit will start on Friday, June 11th and friends and families are encouraged to sign up early since capacity is limited.

Connecting families is an essential component of integrating back into the community and as the COVID-19 restrictions ease Sheriff McFadden continues to encourage residents and their families to stay connected during these unprecedented times. "Safe, humane and professionally managed detention operations is one of the core functions of my Office. Being able to reconnect families and friends with residents during the Father's Day weekend will strengthen social ties and comfort those that are detained in our detention center," says Sheriff McFadden.
