

## PROPERTY DESCRIPTION

All of that piece or parcel of land situate, lying and being in the City of Charlotte, Mecklenburg County, North Carolina, Being more particularly described as follows:

BEGINNING at an existing Iron pipe on the southwesterly margin of the right of way of East Independence Boulevard (U.S. Highway 74) and the easterly line of the Mecklenburg County Property recorded in Deed Book 3825, page 729 in the Mecklenburg County Public Registry and running thence with said margin of East Independence Boulevard, \$39°59'20"E 566.09 feet to an existing iron rebar; thence S09°46'30"W 170.29 feet to an existing iron rebar on the westerly margin of the right of way of Krefeld Drive, sald right of way being 80 feet wide, thence with said margin of Krefeld Drive the following three (3) calls: (1) S50°'00'40"W 160,00 feet to an existing Iron rebar, (2) \$50°00'40"W14.15 feet to an existing iron rebar at which point Krefeld Drive right of way changes to 60 feet wide, (3) with the arc of a circular curve to the left having a radius of 570.24 feet an arc length of 427.73 feet, and a chord bearing and distance of \$28°40'29"W 417.77 feet to a point in the northerly line of the Landstar Development Company recorded in Deed Book 5880, page 974; thence with the northerly line of the Landstar Development Company property the following five (5) calls: (1) S75°58'57"W passing through an existing iron rebar at 5.35 feet for a total distance of 248.37 feet to an existing iron rebar, (2) S89°55'31"W 173,20 feet to an existing Iron rebar, (3)N67°49'35"W 230.94 feet to an existing iron rebar, (4) N23°06'52"E 465.84 feet to an existing iron rebar, (5) N68°55'31"W 74.23 feet to an existing iron rebar, in the easterly line of the aforementioned Mecklenburg County Property, thence following two (2) calls with the easterly line of the Mecklenburg Property (1) N23°06'52"E 177.96 feet to an existing iron rebar, (2) N44°32'10"E 617.28 feet to the point and place of Beginning containing 14.817 acres according to an asbuilt survey prepared by Sam Molone and associates dated September 1, 1994.

### ALSO DESCRIBED AS FOLLOWS:

COMMENCING at a mag nail set in the centerline intersection of East Independence Blvd. (U. S. Highway 74) and Krefeld Drive, THE POINT OF COMMENCEMENT, and runs thence South 59 degrees 53 minutes 08 seconds West 233.50 feet to a rebar found in the western right of way line of Krefeld Drive (80' Public right of way), THE POINT OF BEGINNING, and runs thence from the beginning rebar and with said western right of way line of Krefeld Drive South 50 degrees 01 minutes 14 seconds West 159.95 feet to a rebar found; thence continuing with said right of way line South 04 degrees 49 minutes 11 seconds West 14.17 feet to a x-mark found in said right of way line; thence continuing with said right of way line, a curve to the left, having a radius of 570.24 feet, an arc length of 427.73 feet, the chord being South 28 degrees 34 minutes 41 seconds West 418,00 feet to a nail found in the sidewalk; thence South 75 degrees 59 minutes 30 seconds West passing through a rebar found at 5.55 feet for a total distance of 248.58 feet to a rebar found; thence South 89 degrees 53 minutes 51 seconds West 173.02 feet to a rebar found; thence North 67 degrees 49 minutes 02 seconds West 230.76 feet to a rebar found; thence North 23 degrees 04 minutes 44 seconds East 465.87 feet to a rebar found; thence North 68 degrees 58 minutes 03 seconds West 74.19 feet to a rebar found; thence North 23 degrees 06 minutes 45 seconds East 178.00 feet to a rebar found; thence North 44 degrees 32 minutes 18 seconds East 617.29 feet to a iron pipe found in the southwestern right of way line of U. S. Highway 74 (200' Public right of way); thence with said right of way line South 39 degrees 59 minutes 20 seconds East 566,07 feet to a rebar found in said right of way line; thence South 09 degrees 46 minutes 08 seconds West 170.33 feet to the beginning, containing 14.817 acres or 645,294 square feet more or less.
